Subject to available space, the Club agrees to store the Owner's dinghy, which should not exceed 4.5mts overall length, within the confines of the Club premises for a calendar year starting 1st January till 31st December.

The Club, at its own discretion, may agree to store the dinghy for a maximum of six months preceding the Year of Agreement. In this case, payment must be made in full for the preceding months, worked on a monthly pro-rata, and the the Agreement year.

The cost of storage will be €125 (one hundred and twenty-five euros) for Club members (lasers must have a stackable trailer). In the case of laser dinghies, should the dinghy not have a stackable trailer, then the cost of storage will be €250 (two hundred and fifty euros). Larger boats that need to be stored in the yard will pay €150 (one hundred and fifty euros) should a committee member deem that the boat is too large to be stored inside.

The Club reserves the right to cancel the storage rights, at the discretion of the committee, if it is considered that the dinghy has not been used in 6 months. The owner will be given a notice by email.

The Club reserves the right to refuse any application at any time and/or ask a dinghy owner to remove the dinghy from the Club Premises if and when the need arises.

Payment will be made prior to transporting the dinghy to the Club and the owner must advise one committee member, in advance, before bringing it to the Club.

Under no circumstances will Club keys be given to unauthorised persons.

The Club reserves the right to temporarily move the dinghy from one area to another or place the dinghy on a rack to maximise space. The dinghy will be stored in the designated area as instructed by the Club and no owner shall be entitled

to a permanent area. In addition no work can be carried out on the dinghy inside the premises without explicit permission from a committee member.

The dinghy must carry a valid MMA license. The Club does not provide insurance coverage for the dinghy or any other of the Owner's property in the dinghy, trailer and cover. Moreover, the Owner shall be responsible for damage that the Owner or the Owner's dinghy or equipment may cause to other boats in the Club or to any property of the Club itself. The Owner warrants ownership of the dinghy and that it is fully covered by complete insurance coverage including liability.

All persons will abide by the rules, regulations and statute of the Vikings Sailing Club and must act in a responsible manner.

Jurisdiction

These terms are governed by Maltese law and any disputes are subject to the exclusive jurisdiction of Maltese courts.

The agreement is non transferable.
